ELECTRONIC GAME CALLERS & MECHANICAL DECOYS

Section 220-2-.11 Prohibited Methods and Devices for Hunting paragraph (2) states: "Any electronically amplified bird calls or sound whether real or imitations. Nothing in this regulation shall prevent the use of electronically amplified crow calls. The possession of any electrical device and/or records capable of producing real or imitation bird calls of any type except crow calls in the woods, field, or on the waters of this State shall be a violation of this regulation; and provided further nothing shall prohibit the use of an electronic quail call to recall captive bred quail, provided that person using an electronic quail call has acquired and has in possession a permit issued by an authorized representative of the Division of Wildlife and Freshwater Fisheries, and provided that only banded pen raised quail shall be used and any un-banded birds taken in the recovery pen shall be immediately released."

Section 220-2-.11 Prohibited Methods and Devices for Hunting Paragraph (5) States; "It shall be unlawful for any person while engaged in hunting turkey in this State to use or have in his possession a decoy which had mechanical or electronic parts which makes the decoy capable of movement or producing sound or which can be manipulated to produce movement or sound. It is further provided, however, that no turkey decoys shall be lawful except during spring turkey season in the area of use."

Section Fall Turkey

“Turkeys may not be hunted with the use of traps, snares, nets, hooks, explosives, dogs, live decoys, mechanical or electrical callers or from a boat. Domestically reared turkeys may not be released into the wild.”

Fish and Game Code Section 3012: “It is unlawful to use any recorded or electronically amplified bird or mammal calls or sounds, or recorded or electronically amplified imitations of bird or mammal calls or sounds, to assist in taking any bird or mammal, except non-game birds and non-game mammals as permitted by regulations of the commission.” Section 311(h)—“Electronic or mechanical-operated calling or sound-reproducing devices are prohibited when attempting to take resident game birds.” Sections 475(b)—“recorded or electronically amplified bird or mammal calls or sounds or recorded or electronically amplified imitations of bird or mammal calls or sounds may not be used to take any non-game bird or non-game mammal except coyotes, bobcats, American crows and starlings.” Section 506(c): Prohibition on Electronic or Mechanically-operated Devices. Electronic or mechanically-operated calling or sound-reproducing devices are prohibited when attempting to take migratory game birds. It is unlawful to use electronic or mechanically-operated spinning blade devices or spinning wing decoys when attempting to take waterfowl between the start of waterfowl season and November 30. For the purpose of this regulation, wind-powered spinning blade devices and kites are not prohibited.”

Wild Turkey Hunting Regulations

"It is unlawful to use live or electronic decoys, dogs, recorded calls or bait to hunt wild turkey. An area is considered baited during the presence of and for 10 consecutive days following the removal of bait."

Prohibited Hunting and Trapping Devices

Electronic Calling Devices, "It is unlawful to use a recording or electronic calling device to hunt migratory birds. However, such electronic calling devices may be used to hunt snow, blue and Ross' geese during Conservation Order light goose seasons that occur after Canada goose seasons."

"Illinois law does not prohibit the use of mechanical deer decoys or electronic calls for deer hunting."

Game Calling Devices and Restrictions, "Hand or mouth-operated calls may be used in hunting all species. Mechanical and electronic (digitally reproduced or tape recorded sound) calls may only be used to take groundhogs, coyotes, wild hogs, English sparrows and starlings during daylight hours.

Mechanical and electronic calls may be used to take crows only during crow season. Electronically produced sounds or calls may not be possessed or used while turkey hunting. (301 KAR 2:251, 3:030, 2:140)” Page 3, ‘New This Year’ states, “The use of electronic decoys for turkey, deer and elk hunting is illegal.”

No information or restrictions provided except for waterfowl "In August 2001, the Washington Fish and Wildlife Commission prohibited the use of battery-powered and other electronic decoys for hunting waterfowl. The rule (WAC 232-12-257) applies only to battery-powered and other electronic devices used as decoys. All devices that are powered by batteries (including, but not limited to "quiver/shaker magnets") or otherwise use electric current (including, but not limited to solar or AC power) are prohibited for use in attracting waterfowl in Washington. Other methods of creating motion in decoys are not prohibited (e.g., "jerk-cords", flags, kites, windsocks, and other wind-powered decoys)."
